TERMS AND CONDITIONS

Please read these terms and conditions carefully. These terms and conditions ("**Terms**") apply to the Young's one more sleep offer (the "**Room Offer**"). You will be legally bound by these Terms from the time you request the Offer as part of the Room Offer.

The promoter of the Room Offer is Young & Co.'s Brewery, P.L.C of Copper House, 5 Garratt Lane, Wandsworth, London, SW18 4AQ (the "**Promoter**").

The rooms for the Room Offer are provided by Young & Co.'s Brewery, P.L.C of Copper House, 5 Garratt Lane, Wandsworth, London, SW18 4AQ ("**Gift Provider**").

Opening and closing dates, eligibility

- 1 The Room Offer will run from 01 December 2024 and close on 28 February 2025 or when allocated rooms run out, whichever is soonest (the "**Offer Period**").
 - Rooms booked during the Offer Period are available for stays between 01 January 2025 and 28 February 2025. Pre-defined blackout dates apply including 8th, 14th, 15th, and 22nd February.
- 2 The Room Offer is open to individuals who are aged 18 years or over at the time of participation into the Room Offer.
- 3 The Promoter reserves the right to verify the eligibility of any participant. The Promoter may require such information as it considers reasonably necessary for this purpose and the Room Offer may be withheld until the Promoter is satisfied with the verification.
- 4 Internet access is required to participate in the Room Offer.

Room Offer

- 5 To receive a total of 50% off a two-night stay (the "**Offer**"), participants must:
 - a) Book two-night's stay; and

enter ONEMORESLEEP into the promotional code section on the website (for bookings made between 1 December 2024 to 25 December 2024 only, thereafter no code will be needed) during the Offer Period.
- 6 The participants will then see a reference to their Offer on the booking page of the participating Young & Co's pubs with rooms (the "**Pubs**"). Participants are not obliged to redeem the Offer at any of the participating Pubs.

- 7 Entries must be completed correctly during the Offer Period to be eligible to receive the Offer. All entries completed or received outside of the Offer Period will not be included in the Offer and are not eligible to receive the Offer.
- 8 The Offer must also be claimed before the expiry of the Offer Period and, where the Offer is limited by availability, before any limit on the number of Offers included in the Offer is reached.
- 9 All Offers are subject to availability. There is a maximum equivalent of 1,000 Room Offers available through the Offer Period. If the maximum number of Offers are redeemed, then you will no longer be able to claim your Offer, whether or not you have previously entered the promotional code in the website.
- 10 Entries generated by script, macro, mechanical or other automated means are prohibited and will cause disqualification. Multiple entries made through agents, third parties, organised groups or any entry duplication method will not be accepted and will not be entitled to receive the Offer.

- 14 Provision of the Offer is subject to the discretion of the relevant Pub and the participant providing, upon request by any person authorised by the Promotor at the Pub where the Offer is being redeemed, proof of their eligibility to participate in the Offer (including without limitation proof that they are aged 18 years or over) at the point of redemption.
- 15 The Pubs reserve the right to withhold any Offer:
 - i. from a participant who is unable to prove that they are aged 18 years or over;
 - ii. where the server suspects that the Offer may be provided to someone under the age of 18;
or
 - iii. where the Promoter has advised in advance of certain exclusions.
- 16 Entries that are not submitted in accordance with these Terms and/or that are delayed, damaged, incomplete, altered, illegible or otherwise defective will be disqualified and not eligible to receive the Offer.
- 17 The Promoter accepts no responsibility for entries that are delayed or rendered invalid for any reason beyond its control.
